- 2. Minutes from October Board meeting were approved with changes.
- 3. **Treasurer's Report**: Sabina Li-Pan presented the financial report, \$13,000 under budget so far this year due to new development staff member starting later than expected. The balance sheet reflects stable assets of about 1 Million dollars, the assets are stored in 250 K amounts in several bank accounts for safety. The previous endowment charter has been dissolved, a new charter will be drafted in March.
- 4. **Executive Director** Ric Ambrose presented his report, over 600 people attended the Art of Living Black opening. 120 artists entered the show this year, another reception is organized for the closing on March 8th. Analysis of student geographic location was conducted which showed 49% are West Contra Costa residents, 41% Alameda County, and 10% from other cities. 34% of enrolled studio students are from Richmond, followed by Berkeley at 19% and Oakland at 15%. Meetings were conducted with teaching artists to review the new Studio Operational Manual.
- 5. Juliann Martinez presented the **President's report** on behalf of Hertha Sweet Wong, Strategic Plan will be finalized in early March. Staff salary ranges will be reviewed in March, and today we will discuss the revised Bylaws.

6. Committee Reports:

Sarah Antonich of the **Development Committee**, presented the new Development Committee charter will be presented for Board approval in March. Reviewed preparations for Part Richmond on April 13.

James Wheeler of **Nominating Committee** requested Board members to email him information about prospective Board members.
