Studio Program - RAC increased from offering 12 virtual classes at the beginning of the fiscal year to 32 virtual classes as of the end of the fiscal year. On-site classes remained unavailable for most of the fiscal year due to the pandemic until RAC cautiously offered small classes in the open courtyard later in the fiscal year. In addition, RAC continued to expand virtual Spanish, bilingual, and intergenerational classes.

Exhibitions - Due to the pandemic, no onsite exhibitions took place during the fiscal year; however, RAC held a number of successful, well-received online exhibitions and artist conversations. RAC engaged local youth in art programs which led to exhibitions, in tune with the RAC philosophy of equity, diversity and inclusion. Shortly after the close of FY 20/21, RAC was finally able to open on-site exhibitions in the galleries under very controlled capacity.

Form 990, Part III, Line 4b - Program Service Accomplishments

Art in the Community - Prior to the pandemic, the Art in the Community program focused on teaching in-person art classes at 10 public schools in the area. During the pandemic, RAC teaching artists had no access to any of the local public schools. In addition, the local school district was experiencing a budget crisis. It was not until the latter part of the fiscal year that RAC received limited funding to conduct virtual classes for Mandarin Elementary School. Nevertheless, RAC used this "down time" to redesign its community outreach program to not only collaborate with local public schools, but also to encompass a larger group of youth in the community, bringing arts programming (virtually) to youth in partner community organizations, free of charge. These efforts, as well as providing professional development opportunities to public school teachers to teach art to their students, are expected to ramp up in January 2022, provided COVID infection numbers remain manageable.

Form 990, Part III, Line 4d - Other Program Services Description

Membership enrollments were significantly lower during FY 20/21, as there was no way for members to enjoy some of the usual benefits of this program due to limitations imposed by the pandemic. Membership income is not a significant percentage of our total revenue, even under more normal circumstances.

Marketing efforts were in "high gear" during the entire fiscal year as the means for RAC to reach out to the community, notify them of all the virtual events, and to ensure that RAC had visibility throughout this shelter-in-place period of time. Considering the circumstances, RAC engaged effectively with the community and received accolades for the work performed online both in person and via the press.

The Board Executive Committee determined the adjustment to the Executive Director's salary and approved the process and the subsequent adjustments that were made to staff salaries.
